The listed prices reflect the cost of most content within a content category and may vary for specific sources. This pricing guide is for all UK content available on Westlaw UK. Not all products are available via pay-per-view. (e.g. ICLR, Book PDFs, Lawtel Cases PDFs, Quantum Reports, Index of Legal Terms, etc.)

#### FOLDERS

Saving a document in a folder	There is no charge to save a document or text in a folder. Documents and text in a folder may be accessed at no charge for 12 months after the initial chargeable view. In transactional billing sessions, the initial chargeable view occurs the first time a document is viewed (in or out of the folder). Documents viewed in a folder after 12 months will incur the applicable transactional display charge for the document.
Sharing folders within your organization	There is no charge to share a folder. Documents and text in a shared folder may be accessed at no charge for 12 months after the initial chargeable view by any individual within the organization with whom the folder is shared.
Sharing folders across organizations	There is no charge to share a folder with people outside an organization. Outside the organization, an initial chargeable view occurs the first time a document is viewed; it is charged according to the Westlaw UK subscription plan of the person viewing the document. There is no charge for subsequent views within the following 12 months by anyone within an organization with which the folder is shared.

## SUMMARY

<p>On Westlaw UK, there are three broad categories of chargeable events:</p> <ul style="list-style-type: none"> <li>• Searching for documents</li> <li>• Viewing documents</li> <li>• Offline delivery of documents</li> </ul>	<p>The subscription fee you pay for your Westlaw UK CORE subscription covers search for documents on Westlaw UK, including searching content not included in your plan. A search of all content is therefore included in your subscription fee, even though it may retrieve results from content not included in your plan.</p> <p>The subscription fee also covers viewing documents from content that is included in your plan. When you view documents from content not included in your plan, standard charges apply and you will be billed at the applicable rate for that content. Alerting (excluding continuous alerts) and delivery documents are included in your Westlaw UK CORE subscription.</p>

## TRANSACTIONAL BILLING

<p><b>Billing</b> Under transactional billing, the monthly fee covers:</p> <ul style="list-style-type: none"> <li>• Searching for documents</li> <li>• Viewing documents from content included in your plan</li> <li>• Offline delivery of documents (printing or downloading)</li> </ul> <p><b>Search Charges</b> Search charges for users who have selected transactional billing are included in Westlaw UK subscription plans. For cost recovery purposes, a \$256.00 search charge is incurred for running a search. These charges are listed on your invoice as included charges. Exceptions are noted below.</p>	
<p>Document Display</p>	<p>Each display of a document incurs a transactional charge. Charges vary by content category (see the standard charges chart). The same rate applies, no matter how the document is accessed (e.g., retrieved by citation, accessed from a search result list, or viewed from a KeyCite result list). Charges for viewing documents are included or excluded depending on the content covered by your Westlaw UK subscription plan.</p>
<p>KeyCite</p>	<p>KeyCite charges are included in your Westlaw UK CORE subscription plan. Each citation checked in KeyCite incurs a charge of \$38.00 under transactional billing. KeyCite charges are included or excluded depending on your Westlaw UK subscription plan.</p>
<p>Offline Transmission Charges</p>	<p>There is no charge for printing or downloading documents under transactional billing.</p>
