## Enhanced Prefill – Bank Interest

From 2022, the ATO have introduced some changes to bank interest prefill. This includes a certainty indicator, which can either be **Y** or **N**. If Y, then the ATO has high confidence in the interest amount and you will need to provide an adjustment reason code in order to adjust the amount.

Three new fields have been added to Tax Assistant. They are:

- Indicator imported from the ATO prefilling report. Can be either Y or N
  - Reason Code select from the drop down list. Valid codes are:
    - o C Child account
    - P Joint account partner
    - I Joint account individual
    - N Joint account non-individual
    - o U Unknown amount
    - D Duplicate amount
    - E Previously declared
    - G Incorrect amount
    - F Family law agreement
    - $\circ$  O Other
- Reason description enter a description if code 'O Other' has been selected

Where the Indicator has been marked **Y** and you have adjusted the interest amount without including a reason code, you will receive the following rejection message when lodging the return.

In addition, the following warning validation will appear if you have adjusted the interest amount but did not enter a reason code.

"W001 - If the Interest certainty indicator (ATO Indicator) is "Y" and the prefill interest amount has been adjusted, you need to select a "Reason Code". If Other is selected, you also need to enter the "Reason Description""

- If indicator is Y You must also include a Reason code and Reason description (if code O Other is selected) in order to adjust the interest amount
