By an instrument of abdication dated 10th December 1936 our Sovereign KING EDWARD THE EIGHTH declared his irrevocable determination to renounce the Throne for himself and his descendants, and on the following day His Majesty assented to *His Majesty's Declaration of Abdication Act* 1936, which provided that immediately upon Royal assent being signified His Majesty should cease to be King and there should be a demise of the Crown and accordingly the member of the Royal family next in succession to the Throne should succeed thereto. HIS ROYAL HIGHNESS PRINCE ALBERT FREDERICK ARTHUR GEORGE was thereupon proclaimed King by the title of GEORGE THE SIXTH.
