## PREFATORY NOTE

The publication of this Volume introduces several changes which have recently taken place in law reporting in Tasmania.

Responsibility for all law reporting in Tasmania has by Order-in-Council now been vested in a Council of Law Reporting which consists of the Chief Justice or a judge nominated by him, the Editor, a member of the Faculty of Law at the University of Tasmania and a practitioner nominated by the Law Society of Tasmania.

The name of the Reports has been changed from the Tasmanian State Reports to Tasmanian Reports and the mode of citation has been changed from [1979] Tas. S.R. to 1979 Tas.R. This will be the fourth series of law reports in Tasmania, the others being Nicholls & Stops' Reports, Tasmanian Law Reports, and Tasmanian State Reports.

Other changes to the Reports include the adoption of the practice of repeating on each page the reference to the case being reported and the incorporation of references to cases cited in the text instead of in foot notes.
