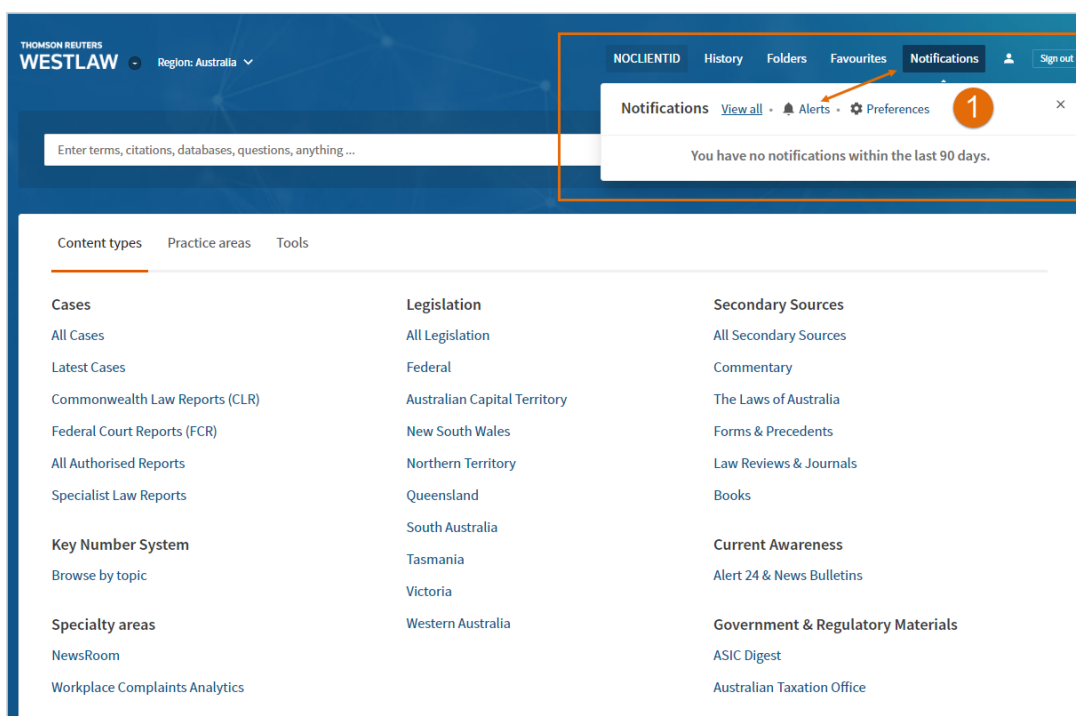
Alert24 provides the latest details on legal and regulatory developments in key areas of practice.

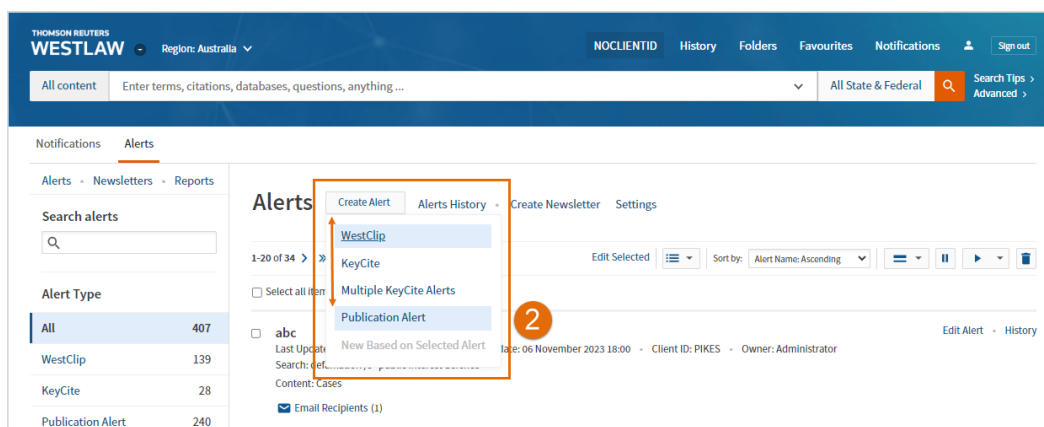

1. Click **Notifications** then choose **Alerts**.



2. Click Create Alert then select Publication Alert.



- Give the alert a name – eg **“Alert 24 – Intellectual Property”** and description as this will help recognise the alert when the email notification arrives. Click **Continue**.

5. In the **Customise Delivery** section type in the recipients email address. Tick the **Allow recipients to unsubscribe from this alert delivery** box to enable this option.

- In the **Format** section, select **Inline HTML** for the best reading experience.
- The default **"What to deliver"** option is to send a **"List of items"**. Selecting **"Documents"** sends the full text of documents in the alert email.
- Leave the **"Include out of plan documents"** box unticked so you do not incur any charges. No further warning on individual out of plan documents in the alerts will be received.
- Click the **Continue** button to schedule the alert.

6. **Schedule Alert** – Choose frequency, the correct time zone, and specify the time you want it to arrive e.g. Daily, GMT +10:00 Canberra, Melbourne, Sydney, 9:00am.
7. Click **Save alert**.
