Use the global search bar to quickly find cases by a citation or party name.

## Finding a case by citation

- 1. Enter the case citation into the global search bar, but do not type any square or round brackets, e.g., **2019 VSCA 251**.
- 2. As you type, Typeahead suggestions will appear in the drop-down. Select the case in the drop-down to display the case.

## Finding a case by Title or Party Name

- 1. Start typing a party name or names into the global search bar, e.g., **Cadbury Schweppes v** Darrell Lea Chocolate Shops.
- 2. As you type, suggestions appear in the drop-down list. Select the required case from the list.
