

### Creating deep links to content in Westlaw

Learn how to create links in your intranet, library catalogue or learning system to content in Westlaw Precision Australia.

#### Link to a case KeyCite record or unreported judgment

1. Click on the Copy menu button.
2. Select Copy citation.



3. Ensure the Add hyperlink to citation box is ticked.
4. Click on the Copy button and use CTRL and V to paste.



If you are a Single Sign On user, you will need to add your Group ID to the end of the URL.

## Link to a law report

5. Ensure you are in the law report version of the case material.
6. Click on the Copy button and use CTRL and V to paste.

4 Duties of Directors

Duty to Prevent Insolvent Trading

Section 588G of the Corporations Act 2001 (Cth)

[4.2.2250] A director is

[4.2.2250] A director is under a duty to prevent company from trading while insolvent.

A director breaches this duty if the director fails to prevent the company incurring debts if there are reasonable grounds for suspecting that it is insolvent. <sup>1</sup> Subject to four alternative defences <sup>2</sup> (see [4.2.2320]) contravening directors are liable to pay compensation to the company of an amount equal to the loss or damage suffered by unsecured creditors for the debts so incurred because of the company's insolvency: <sup>3</sup> see [4.2.2360]. In addition, contravention of s 588G of the Corporations Act 2001 Cth may result in the imposition of a civil penalty order (see [4.2.2340]) or criminal sanction pursuant to Pt 9.4B of the Act: <sup>4</sup> see [4.2.2350].

## Link to a commentary's table of contents

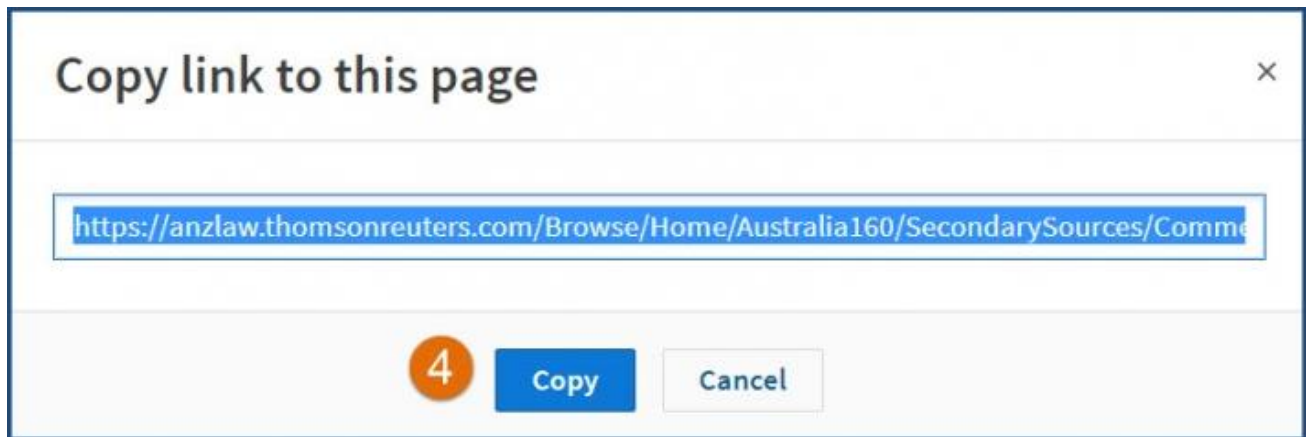
1. Search for the commentary by typing in its name
